#### **Our Fees**

<sup>&</sup>lt;sup>1</sup> A summary only offence is an offence which can only be tried in the magistrates' court. There are exceptions. Under the Criminal Justice Act 1988 (CJA 1988) offences specified in the Act can be tried on indictment by a jury if they are linked to an offence triable only in the Crown Court. The principal summary only offences are:

<sup>·</sup> driving whilst disqualified

careless and inconsiderate driving

<sup>•</sup> failing to give information as to the identity of the driver

<sup>·</sup> failing to stop or report, and

<sup>•</sup> speeding.



Fixed Fee: From £500 + vat

#### What is included?

- Attendance and/or preparation;
- Considering evidence;
- Taking your instructions;
- Providing advice on likely sentence;
- Attendance and representation at a single hearing at the Magistrates Court.

#### What is not included?

- Instruction of any expert witnesses;
- Taking statements from any witnesses;
- Advice and assistance in relation to a Special Reasons<sup>2</sup> hearing;
- Advice or assistance in relation to any appeal.

### Key stages involved

The key stages of your matter are based on the presumption that you have entered a guilty plea and have a date for your hearing. They typically include:

- Meet with your you to provide instructions on what happened;
- Consider initial disclosure, and any other evidence and provide advice;
- Arranging to take any witness statements, if necessary (this will have an additional cost, charged at an hourly rate of £200.00
- Explain the court procedure to you so you know what to expect on the day of your hearing, and the sentencing options available to the Court;
- Conduct any further preparatory work, obtain further instructions from you, if necessary, and answer any follow up queries you have;
- Attend court on the day, meet with you before going before the court. We anticipate being at court for [e.g. half a day].
- Discuss the outcome with you. If advice is required on appeal, this will carry an additional cost.

Please note we cannot provide a timescale of when your hearing will take place, as this depends on the court listing for that day.

<sup>&</sup>lt;sup>2</sup> Special Reasons pertain exclusively to situations where the accused has been found or has pled guilty and now faces disqualification unless he/she can persuade the Court that the circumstances of the offence are such that it would be unjust to impose a ban.



# Motoring offence, summary only, Trial

Each fixed fee set out below is exclusive of VAT and includes preparation for the Magistrates' Court hearing including advice and collation of evidence, representation at court by one of our specialist solicitors and advice on appeal if that is necessary.

Representation at court upon Guilty plea with sentence at a single hearing £500 exclusive

Representation at court upon guilty plea with sentence at a separate hearing £750 exclusive

Not guilty plea and half day trial £1500 exclusive

Not guilty plea and full day trial £2000 exclusive

Additional day or part day of trial £500 exclusive

**Exceptional hardship argument to avoid disqualification** £750 exclusive

Special reasons argument to avoid disqualification Fees as for trials
Half day – £1500 exclusive
Inclusive Full day – £2000 exclusive

Appeal to the Crown Court Appeal against sentence – £1800 exclusive

**Additional Expenses** In addition, some trials will involve the instruction of experts to provide reports such as 'back calculations' where you are alleging post-driving consumption of alcohol. The fee for these reports is not included in the fixed-fess set out above, and there will be an additional cost, often in the region of £300 plus vat

Representation at a more distant court will incur an additional expense of £50 per hour exclusive travel time. Any mileage to more distant courts will be at the inclusive rate of £0.45 per mile with additional disbursements such as parking.



Although unlikely, some cases may be particularly complicated and therefore unsuited to a fixed fee approach. We will identify such cases immediately and provide you with separate advice as to the likely cost to conclusion.
